Key approaching dates

Data locking deadlines:

Inpatient teams: 7th May 2024 (January - March 2024 and April 2023 - March 2024, admissions and/or discharges).

Non-inpatient teams: 7th May 2024 (October 2023 - March 2024 and April 2023 - March 2024, discharges).

Ambulance teams: 22nd April 2024 (December 2023 admissions).


